The General Assembly,

Acknowledging the rich tapestry of global cultural diversity, emphasizing the need for cultural sensitivity and respect in addressing matters related to reproductive health, ensuring that policies and approaches take into account the unique cultural contexts of each nation,

Expressing the commitment of the Democratic People's Republic of North Korea to safeguarding the wellbeing of its citizens, ensuring that policies relating to reproductive health and rights prioritize the protection of human dignity and the preservation of natural values,

Encouraging open and inclusive dialogue among nations, fostering collaboration to share best practices and experiences in addressing reproductive health issues, and recognizing the importance of cooperative efforts in finding mutually beneficial solutions,

- 1. <u>Urges</u> all Member States to promote the termination of a pregnancy only in these certain circumstances, in ways such as, but not limited to:
 - a. Financing healthcare and medical management to ensure equal access for all socioeconomic classes, in ways such as, but not limited to:
 - i. Building new hospitals, especially targeting remote regions,
 - ii. Modernizing medical equipment in public hospitals,
 - iii. Training new medical staff to meet the necessary needs of all type of population with different income;
 - b. Encourage the termination of a gestancy in particular cases, and only such:
 - i. Maternal health risk,
 - ii. Rape due to prostitution,
 - iii. Rape in penal institutions,
 - iv. Pregnancy from government officials,
 - v. Pregnancy from people with disabilities,
 - vi. Pregnancy due to human trafficking;
- 2. <u>Urges</u> all Member States to promote collaboration between countries to advocate for banning abortions, unless cases stated in clause 1, in ways such as, but not limited to:
 - a. Introduce new laws in order to reduce the amount of abortions, in ways such as but not limited to:
 - i. Imprisonment up to 5 years if a non-gynecologist performs an abortion,
 - ii. Fines up to 25,000 dollars if a doctor performs an abortion,
 - iii. Judicial procedures for individuals who attain an abortion without government approval to determine consequences,
 - iv. Death penalty in repeat offenders;

- b. Promote the ideology that abortions are unholy like and considered murder in ways such as but not limited to:
 - i. In social media,
 - ii. In national tv,
 - iii. In newspapers;
- 3. <u>Urges</u> all Member States to educate their citizens on the negative repercussions of abortions such as, but not limited to:
 - a. Informing of psychological issues due to abortions such as, but not limited to:
 - i. Depression,
 - ii. Suicidal thoughts,
 - iii. PAS (Post Abortion Syndrome),
 - iv. Anxiety,
 - v. Isolation,
 - vi. PTSD (Post Traumatic Stress Disorder),
 - vii. Regret and guilt,
 - b. Informing of physical issues due to abortions such as, but not limited to:
 - i. Infections,
 - ii. Uterine perforations,
 - iii. Hemorrhages,
 - iv. Cervical injuries,
 - v. Breast cancer,
 - vi. Allergic reactions to anesthesia and other medicines;
- 4. <u>Strongly</u> suggests all Member States to administer abortion policies that are ethically and legally legitimate such as but not limited to:
 - a. Requiring authorization by a trained medical professional provided by private healthcare and approved by the government,
 - b. Administering abortions under specific circumstances or reason such as but not limited to:
 - i. Fetal impairment,
 - ii. Rape,
 - iii. Incest,
 - **c.** Maintaining consequences for medical professionals, assistants and any party involved in an illegal abortion;
- 5. <u>Urges</u> all Member States to enforce legal consequences for individuals performing or assisting abortions, unless the mother's life is critically endangered, including consequences such as, but not limited to:
 - a. Ensuring prosecution will occur to the people who assisted in the abortion or had it performed on them if the abortion is not legal by:
 - Only having a certain number of licensed doctors allowed to perform an abortion, so that governments will be able to know who performs an abortion and if it is allowed,

- ii. To ensure that this is followed, by having the government have reports made after each abortion,
- b. Governmental acquisition of their assets by:
 - i. Taking the person's assets,
- 6. <u>Calls upon</u> all Member States to implement various preventative measures to decrease the need for abortion among the population, using methods such as, but not limited to:
 - a. Ensuring all young adults, ages 13 to 18, have access to comprehensive sexual education in school by:
 - i. Creating a required curricular class regarding safety sexual relations, methods of contraception, and sexual abuse,
 - ii. Guaranteeing that all schools have at minimum one counselor to ensure that all student concerns are heard and questions are answered,
 - b. Making contraceptive measures widely available in ways which include, but not limited to:
 - i. Ensuring governmentally funded birth control,
 - ii. Adding contraceptive vending machines in public spaces.
